

REALITYWORKS, INC. LIMITED WARRANTY

APPLICABLE TO THE FOLLOWING PRODUCTS: guideWELD® LIVE Welding Guidance System

What this Warranty Covers

Realityworks, Inc. warrants its products against defects in material and workmanship under normal use for 1 year from the original ship date (except the guideWELD LIVE welding hand/angle sensor, Stick Calibration Fixture, Speed Shield, and Speed Shield holding brackets, which will be under warranty for 90 days from original ship date). Speed sensor protective replacement lens, helmet replacement protective lens, and guideWELD LIVE replacement batteries and battery charger are not under the Realityworks, Inc. Limited Warranty. Realityworks, Inc., at its option, will repair the product (with new or reconditioned parts) or replace it (with a new or reconditioned product). Repaired/replacement products or parts are warranted for either 1 year or the remainder of the original warranty period, whichever is longer. All replaced items become Realityworks, Inc.'s property.

What this Warranty Does Not Cover

This warranty does not cover: (a) damage from misuse, use other than normal or customary manner, accident or neglect; (b) damage from improper operation, maintenance, adjustment, alternation or modification; (c) damage from excessive burn or spatter atypical of normal welding training, spills of food, ink, or liquid; (d) all metal, vinyl, or plastic surfaces that are scratched, stained, or damaged due to normal use; (e) damage to our products caused by the use of equipment not supplied by Realityworks, Inc.; (f) products which have the serial numbers removed or made illegible; and (g) repairs that have been made or attempted by others. Any unauthorized repair or modification of the product shall void this warranty.

Do not return any loose parts or any accessories that are not defective with your product to avoid damage and loss in transit.
